**إجراءات التقديم للمساعدات المالية للعام الدراسي 2026-2027 للطلاب
المختارين لإجراءات التحقق**

التحقق: هو عملية يقوم فيها الطالب و/أو الوالدان بتقديم مستندات وإثباتات تؤكد أن المعلومات المُدرجة في طلب طلب مجاني للحصول على المعونة الطلابية الفيدرالية (Free Application for Federal Student Aid, FAFSA) صحيحة.

✓ إذا كانت القيمة الواردة في **البند 5 من Schedule 1** (الملحق الضريبي رقم 1) للنموذج الضريبي 1040 الصادر عن مصلحة الضرائب الأمريكية (Internal Revenue Service, IRS)

✓ ناتجة عن عقار مؤجر، أو عقارات أخرى، أو تأجير جزء من المنزل، فيجب تقديم كشف/بيان رصيد الرهن العقاري يوضح الأرصدة غير المسددة للرهن من جهات التمويل العقاري وذلك اعتباراً من 12/31/2025.

✓ إذا كانت القيمة الواردة في **البند 5** من Schedule 1 للنموذج الضريبي IRS Form 1040 ناتجة عن نشاط تجاري (نماذج 1065 أو S-1120 أو 1120)، فإنه يجب تقديم **جميع** صفحات وجدول الملحق الضريبي الفيدرالي الخاص بالنشاط التجاري لعام 2024، بما في ذلك Schedule L (الميزانية العمومية)، والملحقات Schedule K-1، والنموذج 8825. وإذا كانت هناك عقارات مملوكة للنشاط التجاري، فيجب أيضًا تقديم بيانات أرصدة الرهن العقاري التي توضح المبالغ المتبقية غير المسددة حتى تاريخ 12/31/2025. وفي حال عدم توفر النموذج 8825، يجب تقديم إقرار خطي/بيان مكتوب يتضمن عناوين جميع العقارات المؤجرة.

إلى جانب نسخة السجل الضريبي الصادر عن IRS لعام 2024، يجب تقديم نسخة من كل من Schedule 1 و Schedule E إذا كانت هناك قيمة مدرجة في البند 5 من Schedule 1 الخاص بنموذج IRS Form 1040 لعام 2024
